



Group Basic Life and Accidental Death and Dismemberment Insurance

Group Basic Life insurance from Standard Insurance Company helps provide financial protection by promising to pay a benefit in the event of an eligible member's covered death. Basic Accidental Death and Dismemberment (AD&D) insurance may provide an additional amount in the event of a covered death or dismemberment as a result of an accident.

The cost of this insurance is paid by Clark Atlanta University, Inc.

Eligibility

Definition of a Member	You are a member if you are an active employee of Clark Atlanta University, Inc. and regularly working at least 25 hours each week. You are not a member if you are a temporary or seasonal employee, a full-time member of the armed forces, a leased employee or an independent contractor.
Class Definition	Class 2 - All Other Members, other than President
Eligibility Waiting Period	The eligibility waiting period varies; contact your human resources representative for details.

Benefits

Basic Life Coverage Amount	2 times your annual earnings to a maximum of \$400,000.
Basic AD&D Coverage Amount	For a covered accidental loss of life, your Basic AD&D coverage amount is equal to your Basic Life coverage amount. For other covered losses, a percentage of this benefit will be payable.
Life Age Reductions	Basic Life and AD&D insurance coverage amount reduces to 65 percent at age 70, to 45 percent at age 75 and to 30 percent at age 80.
